Professional Accomplishments

Borough of Manhattan Community College (BMCC), New York, NY, 2010 to present

Director of Institutional Research and Assessment

For over four years, I have led the team in the Office of Institutional Research and Assessment under the guidance of the Dean for Institutional Effectiveness and Strategic Planning. The office is the central source for institutional data about the campus, providing reports, data analysis, projections, and assessment for academic programs and campus administrative departments. Our staff works closely with the faculty and administration to design and implement research and provide data analysis that informs decision-making across the college community. I have emphasized a customer-service oriented approach that takes time to understand the context and objectives of each request we receive to ensure that we provide useful and accurate information that will clearly address the needs of the campus community. We help individuals relate their requests to other recent studies or initiatives that may be underway on campus or elsewhere.

Since 2011, I have been part of BMCC's "Quantway" team, a collaboration among several community colleges organized by the Carnegie Foundation to develop and assess a new approach to teaching math to students who are under-prepared for college-level mathematics. My role has been to work with the data collection and analysis and to contribute to the overall research methodology for the assessment of this project. I am very happy to be presenting an update in July on the highly successful results of the program's implementation at BMCC at the Carnegie Foundation's 2014 Pathways National Forum in San Francisco.

A major focus this past year has been on the need for a new reporting system with the 2013 implementation of the new PeopleSoft Campus Solutions system, CUNYFirst. The familiarity I had gained with this system through working with the data for the faculty workload audits each semester and my prior experience with large database implementation led me to join the BMCC CUNYFirst implementation team. Especially during the early months of implementation, I was called on to help extract some urgently needed operational reports for enrollment management. Most of these requests have now been moved to the Campus Computer Center, but I am continuing to stay involved with the Computer Center as our overall reporting strategy begins to take shape.

My involvement in the Strategic Steering Committee subgroup focused on Student Success brought me a leadership role with a large team of faculty and staff working for over two years on defining the requirements for a new early alert process to replace the paper Academic Warning System which had become less and less useful. The early alert system has been planned as a electronic communication system that would help identify students at risk of failure or dropping out with a process to lead them in a targeted way to student services that could help them succeed. This project is now led by Student Affairs, whose retention coordinators and managers

will work with a group of faculty who volunteered to pilot the new early alert process in Fall 2014 with Hobsons Retain, a newly acquired communications system for student retention.

In my capacity as Director of Institutional Research and Assessment, I serve on the campus Collaborative Improvement Council, and the CUNY Institutional Research Council.

Independent Consulting, 2008 to 2010

Consulting projects since 2008 include work for the SUNY Center for Online International Learning (COIL) where I ran workshops to train pairs of faculty from the USA and other countries who were preparing joint online courses; work for AFS Interculture Canada to provide assessment using the Intercultural Development Inventory (IDI); program development consulting for (ie) Intercultural Experience in Paraguay; as well as individual guidance for two graduate students working on dissertations in projects involving AFS exchange students.

AFS Intercultural Programs, New York, New York, 1980 to 2009

In my 29 years at AFS, I took on a wide variety of roles and worked with a broad range of staff and volunteers located in over 50 countries. I worked directly with the strategic planning, process improvement, educational research, and system implementation initiatives both at the international level, and with a number of individual national-level AFS organizations in Latin America, including the Dominican Republic, Costa Rica, Venezuela, Brazil, Ecuador, and Peru.

Director of Intercultural Education and Research, 2002 to 2009

During this period I directed several educational outcomes assessment research projects, including a landmark 3-year study with Dr. Mitchell R. Hammer involving approximately 2500 students in 9 countries, and a 15-country web survey of AFS program alumni and their peers from 1980-86. In addition I oversaw the research of several graduate students engaged in MA or PhD projects with projects involving AFS students. For several years I was responsible for AFS's performance monitoring indicators on a worldwide basis, and was part of the team creating the key performance indicators for the international organization. I oversaw the annual program quality and satisfaction surveys for AFS in all countries, in which I summarized and analyzed data from students, their parents, their host families and the schools hosting them.

I also launched a new series of AFS orientation and training materials and workshops based on the findings of the Hammer study, and led the project to completely re-work an online intercultural learning program that provides specific guidance and support for exchange students from pre-departure through post-return.

Director, Information Systems, 1995-2002

When AFS lost its director of systems in 1995, I was asked to step into this role where I led the early development of the AFS participant database that is used worldwide for all program and finance data, and continues to evolve under the management of AFS's technical partners in Thailand. I also oversaw the worldwide implementation of Lotus Notes, and personally designed

many of the Notes databases used by the organization.

With the need for disaster recovery looming large after the "Y2-K" issue and 2001, we expanded on a process already in place to duplicate our servers with a firm in Thailand. In 2002 I took a two-month posting based in Peru to guide the implement of the participant database in Latin America. Upon my return I was invited to return to the research and education area, and the systems oversight shifted to the team in Thailand.

The AFS Center for the Study of Intercultural Learning, 1980-1995.

I joined AFS as an assistant to Dr. Cornelius (Neal) Grove, then Director of Research, and from 1980-93 we worked exclusively on research projects and education materials development. The 1981 AFS Impact study, which became my doctoral dissertation, is the best known, but the orientation handbook series and the first edition of my book, The Exchange Student Survival Kit, were both written during this time.

Budgetary constraints around 1990 began to limit our capacity for large-scale research projects, and I was called on to write grant proposals and the in-house newsletter. Through my efforts, AFS in Venezuela, Brazil, and Paraguay received major funding for volunteer development projects from the Kellogg Foundation.

For a few years in the 1990s, I was also the sole writer/editor of the in-house newsletter that was sent to the national AFS offices around the world.
